An estimated 45 million adults in the U.S. lack a credit score at time when credit invisibility can reduce one's ability to rent a home, find employment, or secure a mortgage or loan. As a result, individuals without credit—who are disproportionately African American and Latino—often lead separate and unequal financial lives. Yet, many people who are not recognized within the financial system engage in behaviors that indicate their credit worthiness. We discuss how institutions acknowledge these practices and help these people emerge from the financial shadows, in particular the Mission Asset Fund, a San Francisco non-profit that uses lending circles to help low and moderate income people of color build credit.

The book defends the claims of philosophy (both its possibility and its importance) against attempts to dispute such claims, especially by drawing on the achievements of natural science, by deploying a contrast with what Wittgenstein characterized as the 'dazzling ideal' of science — this ideal incorporates both the imagined completeness of scientific explanation (whereby completing its project would leave nothing unexplained) and the exceptionless character of associated conception of causality. It emphasizes the interconnections between the concepts of "person", "substance", "agency", and "causation" to depict us as creatures capable of making meanings.

A collection of unpublished essays (from lectures and presentations) on the philosophy of Ludwig Wittgenstein, elaborating the reading of his philosophy developed in my *How to Do Philosophy: A Wittgensteinian Reading of Wittgenstein* (2015); and incorporating my inaugural lecture as Professor of Philosophy and the University of Brighton (UK) in 1996.



PATRICIA PÉREZ, Department of Chicana and Chicano Studies

The Tenure-Track Process for Chicana and Latina Faculty: Experiences of Resisting and Persisting in the Academy

Routledge, 2019

This anthology addresses the role of postsecondary institutional structures and policy in shaping the tenure-track process for Chicana and Latina faculty in higher education. At its core, R provides an effective way to handle and manipulate data, which includes operators for calculations on matrices and a collection of tools for data analysis and graphical display.

NANCY SEGAL, Department of Psychology

Accidental Brothers: The Story of Twins Exchanged at Birth and the Power of Nature and Nurture St. Martin's Press, 2018

The book described the life story of two sets of identical male Colombian twins, in which one newborn twin in each pair was accidentally exchanged with a newborn twin in the other pair. My research team traveled to Colombia to gather research data on their similarities and differences, which we provide in the book.

NICOLE SEYMOUR, Department of English, Comparative Literature, and Linguistics Bad Environmentalism: Irony and Irreverence in the Ecological Age

University of Minnesota Press, 2018

While the mainstream media in the global North have typically framed environmentalists as doom-and-gloom killjoys, this book shows how artists and activists since the late 1970s have employed humor, irreverence and playfulness to raise environmental awareness.

ALEXEI SHEVCHENKO, Division of Politics, Administration, and Justice Quest for Status: Chinese and Russian Foreign Policy

Yale University Press, 2019

This book argues that the desire for world status plays a key role in shaping the foreign policies of China and Russia. Applying social identity theory—the idea that individuals derive part of their identity from larger communities—to nations, it contends that China and Russia have used various modes of emulation, competition, and creativity to gain recognition from other countries and thus validate their respective identities. To make this argument, the book analyzes numerous cases, including Catherine the Great's attempts to westernize Russia, China's identity crises in the nineteenth century, and both countries' responses to the end of the Cold War. Combined with historical precedent, this socio-psychological approach helps explain current trends in Russian and Chinese foreign policy.

ROBERT VOEKS, Department of Geography and the Environment The Ethnobotany of Eden: Rethinking the Jungle Medicine Narrative

In the mysterious and pristine forests of the tropics, a wealth of ethnobotanical panaceas and shamanic knowledge promises cures for everything from cancer and AIDS to the common cold. To access such miracles, we need only to discover and protect these medicinal treasures before they succumb to the corrosive forces of the modern world. A compelling biocultural story, certainly, and a popular perspective on the lands and peoples of equatorial latitudes – but true? Only in part. In The Ethnobotany of Eden, geographer Robert A. Voeks unravels the long lianas of history and occasional strands of truth that gave rise to this irresistible jungle medicine narrative.

BOGDAN SUCEAVĂ, Department of Mathematics

Avalon. The Secrets of Happy Emigrants (Original Romanian: Avalon. Secretele emigranților fericiți Polirom Press, Iași, Romania, 2018 and a Second Printing in 2019

This autobiographically-inspired novel tells the story of a graduate student in mathematics in a North American campus, while the flashback memories present the social and political transformations taking place in the 1990s in Eastern Europe in the same historical time. The second printing represents the mass-market paperback of the 2018 novel. Sold the first printing in 5 months since publication.

BOGDAN SUCEAVĂ, Department of Mathematics

Miruna, a Tale (Original Romanian: *Miruna, o poveste*). Translated into Iranian by Babak Mazloumi. Hanooz Press, Tehran, 2018

A village in the Carpathian Mountains, one of the last outposts of pre-modernity, an elderly man, sensing his time is short, tells his young grandchildren tales that weave a family saga covering the real history from the 1870s to the time of the telling. One of the children, now grown, is the re-teller of these tales, while the other, Miruna, perhaps has the gift of second sight.

BOGDAN SUCEAVĂ, Department of Mathematics The Best Writing on Mathematics 2018, Editor Mircea Pitici

Princeton University Press, 2019

Includes our paper: *Quadrivium: The Structure of Mathematics as Described in Isidore of Seville Etymologies*, co-authored with CSUF alumni Isabel Serrano and Lucy Odom. This was originally a paper published in Springer-Nature's 'Mathematical Intelligencer', and a student project, first presented (as a preliminary report) by Isabel Serrano in an American Math Society conference. Our work describes on how mathematics was presented in the greatest "bestseller" of the Middle Ages, an influential work that for about 9 centuries was the most copied book in Western Europe (after the Bible).

BOGDAN SUCEAVĂ, Department of Mathematics

The Night Someone Died for You (Original Romanian: *Noaptea când cineva a murit pentru tine*) Polirom Press, Iași, Romania, 2019

This novel represents the second printing of the original 2010 book published also by Polirom Press, the Romanian leader in local fiction on the Romanian market. The novel describes the Christmas night of December 25-26, 1989, during the Romanian revolution, as viewed and lived by a group of undergraduate students in the central hall of the University of Bucharest.

BOGDAN SUCEAVĂ, Department of Mathematics

Vincent the Immortal (Original Romanian: Vincent nemuritorul),
